The typical lifespan of coatings on the interior and exterior of tanks is around 15 years, so the current coatings have reached the end of their lifecycle. Reclaimed water valve vaults adjacent to the tank will also have coatings and safety improvements made, including lighting improvements, ladder safety systems installed, hatch safety grating installed. Additional needed improvements include: Site Lighting, Grounding, I&C and Cathodic Protection Improvements, Yard Piping and Valve Improvements, including Installation in New Concrete Valve Vault, Coating Improvements, Improvements to tank to Comply with Austin Water Standards, including Safety Improvements
